

Terms & Conditions of Business

Actual and Constructive Notice of Contractual Agreement

Universal Offer of Contract

NON NEGOTIABLE

If you agree to the following terms demonstrate as much by entering into business with me. All words carry the meaning as intended by me. 1. You agree to the agreement in red ink (on the first page) and applies to any/all correspondences (see below in red) including fees for damages and by replying you automatically have agreed with all terms & conditions stated within.
 - i. This is not a complaint, a query, a request for a statement/agreement and is not to be treated as one. by doing so, you will agree to pay (£5,000.00) five thousand GBP in damages.
 - ii. Do not refer to me as Sir/Mr/Mrs/Ms or any title, which is a legal fiction name fraud and is not me. by doing so, you will also agree to pay (£5,000,000.00), 5 million GBP in damages for encouraging me to commit fraud for your benefits.
 - iii. To treat these notices/affidavits/documents/correspondences with the respect they deserve and by not doing so ie re-naming them you also agree to pay (£10,000.00) ten thousand GBP in damages.

 - iii. For answering in bound telephone calls: 50.00 per call, 10 minutes maximum.
 - iv. For making and or initiating telephone calls: 75.00 per call, 10 minutes maximum.
 - v. For any other task involving the use of my time 150.00 per hour or part of.
9. You agree that you will hold my date securely and expressly and exclusively for the purposes of administering this relation and or account on m behalf.
10. You agree that terms may be amended at any time by me and shall be effected by my providing you said amendments with 14 (fourteen) days notice.
11. You agree that all and any disputes will and or shall be decided by an independent arbitration court. Where the terms herein stated conflict with your terms of business you agree that my terms shall and will supersede and take precedence over yours. In other words, your terms shall make way for mine.
12. You agree that at no time are you conveyed gifted granted a Power of Attorney to act as by for STEVEN KIRK except as may be specifically and exclusively expressed in writing by me. i accept the term of your memorandum and association (Chapter) pertaining to bills, acceptances, drafts, promissory notes.
