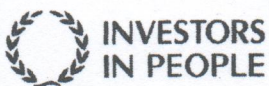

Dear Steven of the family Kirk

Thank you for your letters the contents of which have been noted. I have been asked to reply.

Firstly, I should draw your attention to a number of points regarding the licensing of drivers and the registration and taxation of vehicles. The Vehicle Excise and Registration Act 1994 requires vehicles to be taxed and insured unless they are properly declared as being used or kept off the public road ('a Statutory Off Road Notification'). Vehicles must be properly registered with the DVLA. Vehicles must display a valid registration number.

There are no exceptions or exemptions from these requirements or any other requirements with the registration and taxing of vehicles. If you are stopped by the Police and found to be in breach of the law regarding your vehicle then they will have no option but to report you for the offence. Similarly, if DVLA receive any notification of such a breach then we will have no option but to take the necessary actions to enforce the law.
